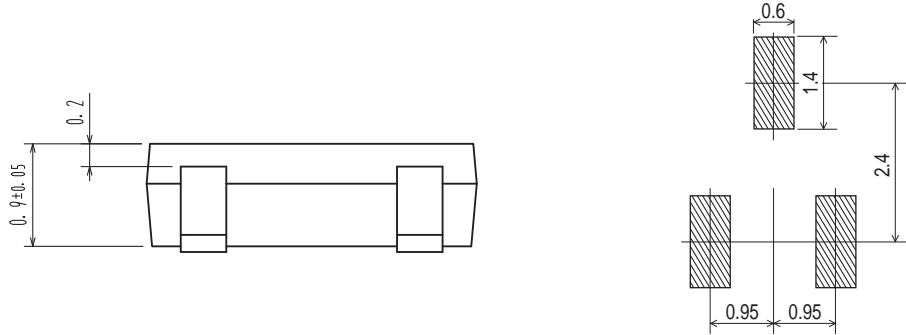
1: Gate

3: Drain



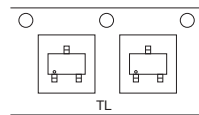
Land Pattern Example



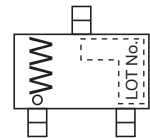

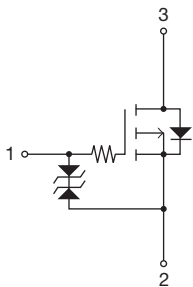

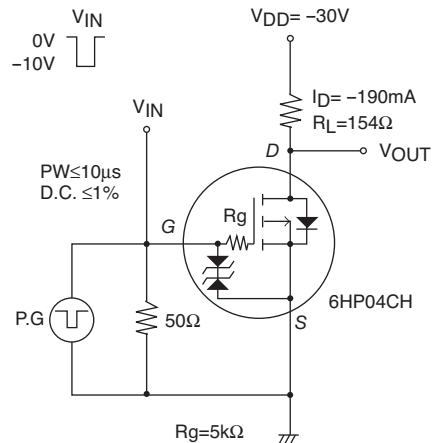
